I plan to allocate the current funds toward purchasing a set of high-quality poms that will be owned by the university. This decision will benefit not only our current team but also future cheerleaders for years to come. By having a shared set of poms, we can avoid the recurring expense of each member purchasing their own, which can be costly, especially for students. This investment will make joining the cheer team more accessible and inclusive by reducing financial barriers for new members. Ultimately, this approach allows us to stretch our budget further and create a lasting resource that strengthens our team year after year.

#### What would you like to spend this grant on? Please include a break down of how the money will be spent.

I would like to use this grant to purchase a durable set of poms that the university will own, which will benefit the cheerleading team for years to come. Here's a breakdown of how the funds would be allocated:

High-Quality Poms – £162.72: This would cover a full set of matching, durable poms in our university colours. Investing in higher-quality poms means they will last longer, reducing the need for replacements.

Storage Solution – £0: To keep the poms in good condition, we would use a pom storage bag that we already own (freshly cleaned) ready for the poms. This protects them from damage during off-seasons and between practices. We would store them in the office protecting them from damp and any damage that may occur from weather damage.

#### Total: £162.30

#### Why do you require this grant? Please be specific.

This approach ensures that the grant is spent in a way that provides lasting value, enabling us to keep costs low for future members and promote accessibility to the cheer team without compromising on quality.

#### If successful, how would this grant develop your club/society?

This grant would be a transformative resource for our cheer team, enabling us to build a more inclusive, sustainable, and financially accessible club. By investing in a shared set of high-quality poms, we could remove the recurring cost of new members purchasing their own equipment, which can be a financial barrier for some students.

Having university-owned poms would also promote a stronger sense of unity and pride within the team, as everyone would be equipped with consistent, professional gear that aligns with our school's identity. The shared resources will also reduce the financial commitment required to join, making the club more accessible to students from diverse backgrounds who may not have considered cheerleading due to upfront costs.

This grant will support the club's growth and longevity, allowing us to focus future funds on enhancing training, expanding team-building activities, and participating in more events and competitions. With the poms and maintenance resources in place, our club can better support our members now and in the future, creating a lasting positive impact.
